

WHEREAS, the North Carolina Department of Transportation's Division of Bicycle and Pedestrian Transportation has announced the availability of Bicycle and Pedestrian Planning Grants for local governments; and

WHEREAS, the Town of Hayesville desires to apply for a grant to develop a Comprehensive Bicycle and Pedestrian Plan to improve connectivity and safety; and

WHEREAS, the Town of Hayesville recognizes the numerous health, well-being, quality of life, and economic development benefits resulting from active transportation options; and

NC Moves 2050

NC Moves 2050 is a plan that will provide a 30-year transportation vision and implementation plan for the state. Due to COVID-19, draft recommendation comment period will be during the month of June 2020. As it gets closer to the comment period, addition information and a 3 to 5 minute video of the draft recommendations will be provided.

Strategic Transportation Corridor Studies (STCs)

The STCs are intended to promote transportation system connectivity, provide high levels of mobility, and improve access to important state and regional activity centers. NCDOT has initiated the development of a master plan vision for STC U - U.S. 74 from I-26 in Polk County to U.S. 117 in Wilmington and Corridor D – U.S. 321 from the South Carolina state line to the Tennessee state line. Surveys for these corridors are available through June 6, 2020.

US Census

The Census Bureau has temporarily suspended 2020 Census field data collection activities in March. Steps are being taken to reactivate field offices beginning June 1, 2020, in preparation for the resumption of field data collection operations as quickly as possible following June 1. At this time, the census Bureau is seeking statutory relief from Congress of 120 additional calendar days to deliver final apportionment counts. Under this plan, the Census Bureau would extend the window for field data collection and self-response to October 31, 2020, which will allow for apportionment counts to be delivered to the President by April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021.

NCDOT is accepting applications from communities for the 2020 Bicycle and Pedestrian Planning Grant Initiative. The program provides funding for municipalities across the state to develop comprehensive bicycle or pedestrian plans.

All North Carolina municipalities are eligible to apply for a standard bike or pedestrian plan. Additionally, the following options are available:

- Counties with populations of less than 50,000 may apply for a bicycle or pedestrian plan.
- Smaller municipalities with populations of less than 10,000 can also apply to develop combined bicycle and pedestrian plans.
- Municipalities of less than 5,000 population may apply for a Project Acceleration Plan an abbreviated plan
 primarily focusing on priority project identification and implementation.
- Municipalities (and counties with populations of less than 50,000) with a bicycle or pedestrian plan may also apply to update their plan if it is at least five years old.

The deadline for applications to be submitted electronically is **May 19 at 5 p.m**. Award recipients will be notified by September 2020.
